

myJAZZ Connection Fantasy Contest

OFFICIAL CONTEST RULES

1. **How to Enter the Contest:**

(a) During the 2008-09 NBA regular season, Jazz Basketball Investors, Inc., dba the Utah Jazz (the "Jazz") will conduct six "Jazz Fantasy" contests (collectively the "Contest"), as more particularly described in these Official Rules. There will be one winner for each month of the 2008-09 NBA regular season (November, 2008 through April, 2009 - six total winners). The Sponsor of the Contest is Jazz Basketball Investors, Inc. dba the Utah Jazz, 301 West South Temple, Salt Lake City, UT 84101.

(b) The Contest may only be entered by the Internet through my.utahjazz.com during the Contest period (from 12:01 am Mountain Daylight Time on November 1, 2008 through beginning of the final regular season Jazz game during the 2008-2009 NBA season). To participate in the Contest, participants must log onto my.utahjazz.com and follow the instructions to register and obtain a valid Portal Account. Participants must submit their entries on the official form. Each valid entry will be entered into the Contest. Each month the winner of the Contest will be the person who aggregates the most "points" during that particular month for all Utah Jazz games. Each valid entry will earn a "point" for each correct prediction of the players who record the most points, assists, rebounds, steals, blocked shots, field goal percentage, made free throws and made 3-point shots during each Utah Jazz game in that given month during the 2008-09 NBA regular season. One point will be awarded for each correct prediction in each category for each game. For example, if a qualifying entry correctly predicts that Player A will record the most points during a given game, and that Player B will record the most assists during that game, that valid entry will receive two points. Following the end of the final Utah Jazz game of each month during the regular season, all of the points for that month will be counted, and the person who received the most points (i.e., most correct predictions) during that month will be the monthly winner. In the event of a tie in the total number of points scored during a month, a random drawing from among all persons who scored the highest number of points that month will be held to determine the monthly winner of the Contest. Each monthly winner of the Contest (either the one person with the highest number of aggregate points for the particular month or the winner of the random drawing) will win the prize designated for the Contest. Only one prize will be awarded each month to one monthly winner of the Contest.

(c) Sponsor is not responsible for technical or computer failures, errors or data loss of any kind, lost or unavailable Internet connections, or failed, incomplete, garbled, delayed or deleted computer or network transmissions, inability to access any Web site or online service, or any other error or malfunction, or late, lost, illegible, mutilated, incomplete, incorrect, inaccurate, misaddressed or misdirected entries, or theft or destruction or unauthorized access to or alterations of entry materials, whether caused by the participant or by any of the equipment or programming utilized in this Contest. If, for any reason, the internet portion of the Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest, and to disqualify any participant who tampers with the operation of the Contest or Web site or violates these Official Rules of the Contest. If the Contest is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at my.utahjazz.com, and the winner will be selected from among all eligible entries received prior to the termination date. Caution: Any attempt by a participant to deliberately damage any Web site or undermine the legitimate operation of the Contest is a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek damages from any such participant to the fullest extent of the law.

(d) In the event of a dispute regarding the identity of an electronic participant, electronic entries will be deemed submitted by the authorized account holder of the email submitted, as of the time of the entry.

(e) Odds of winning depend upon the number of eligible entries that score the highest number of "points", as described above in these Official Rules.

2. Eligibility Restrictions:

(a) The Contest is open to residents ages 18 and older living within a 75 mile radius of EnergySolutions Arena. Employees of the Utah Jazz, the Larry H. Miller Group of Companies, Zion's Bank, the National Basketball Association and its Member Teams, NBA Properties, Inc., and of their respective affiliates, parents, subsidiaries and advertising agencies, and the directors, governors, employees and agents of such entities, and the immediate family members of all such

persons, are ineligible to participate or win.

(b) All entries become the sole property of Sponsor and will not be returned. By entering, each participant agrees to abide by these Official Rules and all decisions of Sponsor (which are final in all matters). No correspondence will be acknowledged. Entries may be used for advertising and/or trade purposes without compensation unless prohibited by law.

3. Prize:

(a) The winner of each monthly Fantasy Contest will receive one (1) Utah Jazz jersey autographed by a member of the 2008-09 Utah Jazz team. Any other expenses not expressly provided for in these Official Rules are the responsibility of the winner(s). Approximate value of each monthly prize is \$350.00 dollars.

(b) Sponsor reserves the right to validate all claims made in entries.

(c) Each winner will be notified by email (which will be sent to the email address submitted in the winner's entry information) or by telephone, within 24 hours after being selected. The winner's names may appear on the my.utahjazz.com Web site. IF SPONSOR IS UNABLE TO CONTACT A MONTHLY WINNER BASED ON THE INFORMATION CONTAINED ON THE ENTRY FORM WITHIN TWENTY-FOUR (24) HOURS OF THE SELECTION, AN ALTERNATIVE MONTHLY WINNER WILL BE SELECTED BY THE JUDGES BY RANDOM DRAWING FROM AMONG THE REMAINING ENTRANTS THAT MONTH WHO SCORED THE HIGHEST NUMBER OF POINTS. EACH MONTHLY WINNER MUST SIGN A WINNER'S AFFIDAVIT OF ELIGIBILITY AND RELEASE WITHIN THREE (2) DAYS OF NOTIFICATION, OR THE PRIZE WILL BE FORFEITED AND AN ALTERNATIVE WINNER CHOSEN BY THE JUDGES.

(d) Each participant agrees to follow these Official Rules and hold harmless and indemnify the Utah Jazz and/or the National Basketball Association and its Member Teams, NBA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, directors, officers, employees and agents against any and all liability, damages or causes of action (however named or described), with respect to or arising out of the participant's participation in the Contest.

(e) Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash. Sponsor reserves the right to substitute a prize of comparable value at Sponsor's discretion.

(f) Decisions of Sponsor with respect to the Contest are final.

(g) No more than the advertised number of prizes will be awarded.

4. Conditions:

(a) Payment of all federal, state and local taxes are the sole responsibility of the prize winner and each prize winner each may receive an IRS Form 1099 or equivalent from Sponsor. All federal, state and local laws apply.

(b) All expenses on receipt and use of a prize are the sole responsibility of the prize winner. Each prize winner, by accepting the prize, (i) agrees to release, waive, discharge, hold harmless and indemnify Sponsor, the National Basketball Association and its Member Teams, NBA Properties, Inc., and each of their respective parents, affiliates and subsidiaries, and their respective advertising, promotion and production agencies, and each of their respective officers, directors, employees and agents from and against any and all liability, damages, claims or actions of any kind whatsoever, whenever the same may accrue, for injuries, damages or losses to persons (including death) and property which may be sustained in connection with the receipt, ownership or use of the prize or while preparing for, participating in, and/or traveling to any prize-related activity, whether such claims or actions are on behalf of the participant or the participant's heirs, representatives, administrators or assigns; and (ii) grants to Sponsor, the National Basketball Association and its Member Teams, NBA Properties, Inc., and each of their respective parents, subsidiaries and affiliates the right to use the winner's name, voice, picture and/or likeness for purposes of advertising, broadcasting, trade purposes and publicity in any and all media now known or hereafter invented, without further permission, notice or additional compensation (except where prohibited by law).

5. Miscellaneous:

(a) Sponsor reserves the right to make changes in the Official Rules of the Contest, which changes will become effective upon announcement.

(b) No purchase is necessary. The Contest is void where prohibited by law.

(c) Failure to comply with the Official Rules of the Contest will result in a participant's disqualification.
